Dear Clean Fuel Connection Customer:

Thank you for giving Clean Fuel Connection, Inc. (CFCI) the opportunity to be your electric vehicle charging infrastructure provider. CFCI plans to continue providing high quality infrastructure services in the future, both for your EV charger and for our newest clean energy products and services.

The purpose of this letter is to let you know that CFCI has received word of a price increase from Toyota (TMC), the only provider of the small paddle inductive chargers. The change will occur at the beginning of 2004. Although the new price has not yet been announced, we expect that it will be a significant increase over the current pricing.


We are writing to inform you of this change as early as possible so that you may project your future charger needs and order equipment at the current retail price of \$2,500 per charger. In order to guarantee the existing pricing, we need to receive your purchase order no later than December 31, 2003. At the time of your order, we will give you an estimated delivery date for your equipment. Since production capacity for the chargers is limited, the delivery schedule will depend on the backlog of orders. The lead time for delivery is presently 120 days but that could change if there is a backlog of orders. Unfortunately, we cannot currently guarantee pricing or availability for any charger orders received after the effective date of the price increase as TMC plans to have only very limited production of the TCG 2000 charger after the price change.

CFCI will continue to provide equipment, installation, and service. You may be interested to know that we are also providing consulting, equipment sales and installation services for many alternative fuel and renewable technologies in addition to electric vehicles.
